



## Tenure-Track Assistant Professor – Mathematics Education

**Responsibilities:** The faculty member is expected to sustain a balanced portfolio of research and scholarly activity, teaching, and service. Primary **research and scholarly activity** responsibilities include developing and maintaining an active, productive, and high profile research agenda: publications in leading, peer-review journals, books, and proceedings; active and visible participation in and service to local, state, national, and/or international professional organizations; and leading and co-leading grant applications to local, state, national, and/or international agencies seeking internal and external funds to support research agenda. Primary **teaching** responsibilities include teaching undergraduate and graduate students, online and on campus courses; developing and revising undergraduate and graduate courses; mentoring undergraduate and graduate students; supervising and coordinating undergraduate and graduate students' field experiences; and chairing and serving on doctoral students' dissertation committees. Primary **service** responsibilities include serving on department, college, and university committees as well as service to the professional community; coordinating and managing undergraduate and graduate degree programs; and offering and providing expertise to local, state, and national groups and community organizations.

**Qualifications:** Qualifications include: earned doctorate in Mathematics Education or relevant field with a mathematics education focus; experience in and commitment to working with diverse students in urban schools; and expertise in standards-based mathematics teaching and learning. Successful applicants will have 3 years of professional experience with 6–16 students. A clearly articulated research agenda through publications and presentations is a plus, along with experiences teaching mathematics at the middle school, high school, or undergraduate level as well as teaching mathematics and/or mathematics education courses in a university setting.

**Deadline and Process:**

Applicants should submit a letter of interest establishing qualifications for the position, curriculum vitae, official transcript of highest degree earned, two samples of scholarly work or works in progress, and three letters of recommendation from individuals within the field of interest.
